In producing herewith one arrested accd. person namely Raju Pashi (65yrs) S/o Lt- Kameswar Pashi of Village- Para Intar Harimandir, PS- Para, District – Purulia with seized article i.e 26 (Twenty Six) sealed bottles of Country Spirit styled as “DIL Se” each Bottle contains 600 ml in which 01 (One) bottle as sample which were seized under proper seizure list.

I beg to submit that on 30.11.2018 during my mobile duty in between 19.15 hrs to 19.35 hrs acting on a trip off a raid was conducted in the house of Raju Pashi S/o Lt- Kameswar Pashi of Village- Para Intar Harimandir, PS- Para, District – Purulia and found that the above noted person was keeping and selling Country Spirit which were kept in his house. On demand he failed to produce any valid document in respect of keeping and selling of said liquors. As such I seized 26 (Twenty Six) sealed bottles of Country Spirit styled as “DIL Se” each Bottle contains 600 ml under proper seizure list in presence of witnesses duly signed by them and also arrested the above noted accd. person.

The above noted arrested accd. namely Raju Pashi S/o Lt- Kameswar Pashi of Village- Para Intar Harimandir, PS- Para, District – Purulia committed offence u/s 46 A(c) B.E. Act. 1909 for unauthorized possession and sale of said liquors.

Under the above fact and circumstance I therefore pray that a case u/s 46 A (c) B.E. Act'1909 may kindly be started against Raju Pashi S/o Lt- Kameswar Pashi of Village- Para Intar Harimandir, PS- Para, District – Purulia and arrange for its investigation.
