Dear Sir,

I do hereby lodge a complaint being empowered by the Electricity Act. 2003 to the effect that MD **SARFUDDIN ANSARI**, S/O- LATE DAUD MIA of VILL-Bahara, P.S.-Para, Dist-Purulia, the user of the electric has committed an offence of theft of electricity under section 135 (1) (a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007.

On 04.12.2018 at about 5:45PM, I GOUTAM KUMAR MANDAL, SM of DUBRA PARA C.C.C, along with MrAvishek Das, SAE(E) of Dubra Para CCC and Alok Kr Pandey,HG GR-I TSH, Dubra Para CCC inspected the premises of **MD SARFUDDIN ANSARI**, S/O- LATE DAUD MIA of VILL-Bahara, P.S.-Para DistPurulia WBSEDCL. During inspection it was found that the said **MD SARFUDDIN ANSARI**was enjoying electricity unauthorizedly by direct hooking by cable as hooking arrangement from WBSEDCL's nearest low tension over head line for running his 03nos 100 w bulb, 04 nos 65 watt ceiling fan, 01 no 75 watt TV and 03 nos 9watt CFL approx load 0.662 KW for Domestic purpose, which is an offence u/s. 135 (1)(a) of Electricity Act. 2003 read with the amendment of Electricity Act. 2007.

As electricity theft was detected, his service line has been disconnected and seized as token and labeled by preparing Seizure list at site. Due to theft of electricity a loss of revenue was incurred to the WBSEDCL. The inspection team left the site at about 6:00PM.

As such **MD SARFUDDIN ANSARI**, S/O- LATE DAUD MIA of VILL-Bahara, P.S.-Para Dist- Purulia has committed an offence of theft of electricity under section 135 (1)(a) of Electricity Act. 2003 read with amendment of Electricity Act. 2007. So, you are requested to take cognizance of this offence of theft of electricity treating this complaint as F.I.R.
