Dear Sir,

I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri RAFIK ANSARY [Present User] S/O- ABEDIN ANSARY of Village- RANIPUR (UPARKULI) P.O- SANKRA , P.S- PARA , Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 12-12-2018 at about 11:45 am I, Sri Santanu Sinha, Station Manager Anara CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of Rafik Ansary , S.O- Abedin Ansary of Village- Ranipur Uparkuli , P.O- Sankra , P.S- Para , Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e.  he/she was using Electricity dishonestly by direct tapping from inside of service cable.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- i) LED BULB - 7 nos x 20 watt = 140 watt
- ii) Fan - 8 Nos (6-ceiling + 2 stand) = 720 watt
- iii) Pump - 746 watt
- iv) Bulb (100 watt) x 4 Nos = 400 watt
- v) Fridge = 2 Nos => 360 watt
- vi) TV - 1 Nos = 120 watt

Out of which we seized the following:

- i) tapping incoming service cable (3m)
- ii) 1 No 100 watt Bulb

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list.

The inspection team left the above premises at about 12:10 pm on dated 12-12-2018 .The accused person has committed an offence U/S-135(i)....b..... of the Electricity (Amendment) Act-2007.

You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
