Entered the premises of Maniruddin Ansary , S.O-Lt Jan Mohammad Ansary of Village-Duarimahal , P.O-Lipania , P.S- PARA , Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by direct hooking from LT overhead line.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- ① 2 NOS Fan -(80x2) = 160 watt
- ② 2 NOS LED Bulb -(20x2) = 40 watt

Out of which we seized the following:

- ① Approx 10 m of PVC wire along with hooking device.

The seizure list are prepared at the site and the accused person refuse to signed in the seizer list .

The inspection team left the above premises at about 4:40pm on dated 13.12.2018 .The accused person has committed an offence U/S-135(i)(a).... of the Electricity (Amendment) Act-2007.
