Sir,

In producing here with the arrested accused Sagar Osta (22) S/o Kismot Osta of Village- Bamunbaid, PS- Para, Dist- Purulia and one seized improvised country made firearm having length 10.2 inch approx from butt to barrel, 5.2 inch barrel, having firing pin and trigger along with One (01) round ammunition. Today on 17.12.18 at 20.45 hrs when I along with force were performing mobile duty at Tentulhity Morh received a credible source information that one person is coming from Santaldih side towards Dubra possessing a gun with him. I informed the matter to O/C Para PS. I also briefed the information to my accompanying force. Sometimes later at 21:15 hrs found that one person is coming from Santaldih side. When the person came near to Tentulhity morh seeing the Police party he started to run to hide himself in the dark of night. We chased him and after a hot chase we able to intercept him in front of Tentulhity morh. On search found that he possessed one improvised country made firearm at right side of his waist and in left side pocket of his pant there is 01(One) rd ammunition. On asked he disclosed his identity as Sagar Osta S/o Kismot Osta of Village- Bamunbaid, PS- Para, Dist- Purulia and on demand he could not able to produce any license or valid document in respect of possessing or carrying of that improvised fire arms. Finding no other alternative I arrested him after informing him the ground of arrest and after observing all legal formalities and also seized the improvised country made firearm along with 01(One) rd ammunition from the exclusive possession of the arrested accused person Sagar Osta under proper seizure list in presence of witnesses duly signed by them. As it is dark of night no public witness was available.

Under the above circumstances I pray before you for starting a case under proper section of law against accused Sagar Osta S/o Kismot Osta of Village- Bamunbaid, PS- Para, Dist- Purulia for possessing and carrying of improvised country made fire arms and arrange for its investigation.

Deceived on-17.12.18 at 22.25 hours and started para prisicase No-147/18 dt- 17.12.18 uls- 25(1-A)/27 Arm Act.
