Sub: Request for lodging F.I.R. against accused (1) Belbaran Tudu(42) S/O Lt. Balai Tudu(2) Babulal Mandi(40) S/O Lt. Boyel Mandi (3) Biswanath Mandi(30) S/O Baidyanath Mandi all are village Petarigora, PS- Puncha Dist- Purulia. U/S- 46A(C) of B.E. Act 1909.

Sir,

In producing herewith arrested accused person 1) Belbaran Tudu(42) S/O Lt. Balai Tudu(2) Babulal Mandi(40) S/O Lt. Boyel Mandi (3) Biswanath Mandi(30) S/O Baidyanath Mandi all are village Petarigora, PS- Puncha Dist- Purulia under Arrest Memo, Inspection Memo along with seized articles viz. (i) 35 (Thirty five) bottles of Country Spirit designed as 'Dil Se' (each bottle contains 375 ml of country spirit having strength 80° UP being sealed properly), (ii) Two white coloured plastic jarican having approximate 20 Ltrs. Of ID liquor, (iii) one fanel (maker) (iv) one bottle of 'Dil Se' as sample of Sl. No. (i), (v) one bottle of ID Liquor (500 ml.) as sample of Sl. No.- (ii), (vi) 03(three) plastic glasses, under proper seizure list and being labeled properly, I beg to report that today at 13:05 hrs, received a telephonic information from my source that three persons namely (1) Belbaran Tudu(42) S/O Lt. Balai Tudu (2) Babulal Mandi(40) S/O Lt. Boyel Mandi (3) Biswanath Mandi (30) S/O Baidyanath Mandi all are village Petarigora, PS- Puncha Dist- Purulia was selling ID liquor and country spirit at Petarigora under Puncha PS illegally. Accordingly obtaining permission from O/C Puncha PS I ASI Aloke Chatteraj along with force left for working out the information. We reached at Petarigora and keeping the vehicle at a reasonable distance we proceeded to the house premises of said Belbaran Tudu as being shown by the source from distance. We entered in the house of Belbaran Tudu and found three persons was selling ID liquor and some persons were drinking in the courtyard of the house. Seeing the police all persons fled away leaving some plastic glasses but they could not flee away. We apprehended them and on searching the house we recover 35 (thirty five) bottles of 'Dil Se', 02 (two) plastic jarican each of them contains 10 ltrs (approx) of ID liquor, one fanel (maker), three PCs, plastic glasses. On being interrogated the youth revealed their identity as 1) Belbaran Tudu(42) S/O Lt. Balai Tudu (2) Babulal Mandi(40) S/O Lt. Boyel Mandi (3) Biswanath Mandi(30) S/O Baidyanath Mandi all are village Petarigora, PS- Puncha Dist- Purulia. On asked they could not produce any license in favour of selling, keeping or possessing ID liquor or country spirit and they confessed that they there collaborately run this illegal business at the premises of Belbaran Tudu. Accordingly I seized 35 (thirty five) bottles of 'Dil Se', 02 (two) plastic jarican each of them contains 20 ltrs (approx) of ID liquor and 03 (three) plastic glasses and one fanel (maker) from their possession after labeling and sealed properly and took sample of each of the items and arrested them observing all the formalities regarding arrest as their offence comes under the section of 46A(c) of B.E. Act 1909.

Hence a specific case may kindly be started and arrange for its investigation.
