Sir,

In producing herewith the arrested accd, person namely, Ruban Mukherjee (27) 5/O-Nabagopal Mukherjee of village Bishpuria, PS- Puncha, Dist. Purulia with arrest Memo, Inspection Memo and seized articles viz (1) one iron made single bore country made fire arms having length of 9 1/2 Inch (approx) with butt, barrel, firing pin, etc. Barrel length 5 1/2 inch (approx). (2) two live ammunitions of 8 MM KF (3) One Black colour school bag under proper seizure list and being labeled properly, I beg to inform you that today (05.12.18) at about 16.45 hrs. while myself along with force was performing evening mobile duty(vide CC No 2701 Dtd 05/12/18) at Dhadki more, I received a telephonic information from my reliable source that one youth namely Ruban Mukherjee of about 27/28 Years was loitering suspiciously near Bishpuria village, under Puncha PS and he had a bag with him in which there was a fire Arms & ammunitions. Accordingly I consulted with O/C Puncha PS and as per his direction at 16.55 hrs, I., along with C/240 Manoranjan Bagdi & C/ 1487 Tarani Sen Das, on mobile duty started for working out the information after briefing them properly about the gravity of the information and my plan to nab him . We reached at Bishpuria side at around 17.05 hrs and keeping the vehicle parked in a safe place we proceeded to the spot on feet. On reaching there we found one youth walking towards Bishpuria village and accordingly we apprehended him and on asked he identified namely Ruban Mukherjee (27) S/O- Nabagopal Mukherjee odf village Bishpuria, PS- Puncha, Dist. Purulia and we recovered a black colour school bag from the possession of Ruban Mukherjee and on searching from the bag recovered (1) one iron made single bore country made fire arms having length of 9 1/2 Inch (approx) with butt, barrel, firing pin, etc. length of the barrel is 5 1/2 (approx) and (2) two live ammunitions of 8 MM KF and on demand he failed to produce any papers in respect of the Fire Arms and Ammunitions while searching his body nothing could be recovered. Accordingly I seized the same under proper seizure list and on interrogation he confessed his guilt of keeping the same. I arrested him observing all the formalities regarding arrest.

Hence I pray that a specific case may kindly be started against above noted arrested accused person under proper section of law and arrange for its investigation.
