Sub:- Complaint for illegal trading of paddy and creating obstruction to the Government Scheme at Centralized Procurement Centre under Purulia-II.

To arrest the distress sale among the farmers, the Govt. has introduced paddy purchase programme in this K.M.S 2018-2019. But to run smoothly this programme we are facing some trouble by few paddy traders/brokers at Purulia-II Kishan Mandi, Hatuara. They are named (i) Mitan Duari, S/o- Baldeb Duari (ii) Jayanta Duari, S/o- Ambarish Duari (iii) Rakhahari Duari, S/o- Karuna Duari (iv) Dhananjoy Duary, S/o- Madan Duari all of Vill- Ramdih (v) Sahar Ali Ansary, S/o- Sahaban Ali Ansary of Vill- Dakshinbahal (vi) Muruli Gorai, S/o- Lt. Fanibhusan Gorai of Vill- Bhangra and others all of under Purulia (M) P.S, Dist- Purulia.

At the beginning the above paddy traders are purchasing paddy illegally and creating pressure to us to buy their inferior quality paddy. Today (21-12-18) at about 12.00 o' clock they came to the C.P.C together and sold paddy by another person's Bank Account number and they used criminal force to deter public servant for discharge of our office duty and public function to smooth run this programme. So, you are requested to take necessary action in this regard so that from tomorrow we can continue this Govt. Programme paddy purchase at Centralized Procurement Centre Purulia-II Kishan Mandi smoothly.
