Respected Sir,

In producing herewith arrested Accd. Person namely Dhanukdhari Gope (27 yrs) s/o Prasanna Gope of Vill- Telidih, P.S.- Purulia(M), Dist.- Purulia and seized (i) 35(thirty five) Bottles DIL SE as sealed condition(ii) 02(two) $\frac{1}{2}$ bottles DIL SE (iii) 05 (five) empty bottles of DIL SE (iv) 07 plastic glass (v) 02(two) $\frac{1}{2}$ bottle of water.(vi) one bottle DIL SE taken from SL No I as sample.

I beg to submit that on today 01.12.18 in course of my mobile duty myself along with force reached at Telidih village at about 01:45 hrs and found one person keeping & selling of liquor from his house situated at Telidih village and seeing the police party two/three persons fled away from his house and then there held raid and managed to apprehended one .On being asked his identity he disclosed his identity as noted above and also stated that he is the owner of the house and he himself selling and keeping the said Liquor and confessed his guilty. On demand he failed to produce any valid documents in respect of stock and selling of liquors at his "house" and could not give any satisfactory answer for selling and keeping of liquor. So, I seized the above noted articles under proper seizure list duly signed by the witness & accused person and labeled by me. I arrested him after informing the ground of arrest and also issued Arrest Memo as per Cr.P.C. After arrival at Purulia (M) P.S I put the above noted arrested accd. Person in P.S lock up after maintaining all formalities as per law.

I then thoroughly and carefully enquired in to the matter and from enquiry it reveals that the above noted Accd. person as well as the owner of the said "house" running the clandestine business since long which comes under the purview of section 46 of B.E.Act.

Under the fact and circumstanced I therefore pray a case U/S 46 B.E.Act. may kindly be started against Accd. Person Dhanukdhari Gope (27 yrs) s/o Prasanna Gope of Vill-Telidih, P.S.- Purulia(M), Dist.- Purulia.
