1. That the complainant, accused persons and the witnesses are the residents of Village Keshargoria within P. S Manbazar and the incident also took place at Village Chakaltor at "Chhata Mela" ground within P. S. Purulia (M) and within the District of Purulia.
2. That on 17.09.2018 at village Chakaltor a festival namely "Chhata Mela" used to observe in every year and mainly the Adibasi People and also other sects of people use to participate and observe the said "Chhata Mela".
3. That on 17.09.2018 the defacto Complainant and the witness No. 1 Amit Singh Sardar had been to Chakaltor Village to enjoy the Chhata Mela.
4. That the accused persons, who are the co-villagers of the defacto complainant, had been to the said "Chhata Mela".
5. That due to previous grudge and enmity, at about 7.30 P.M. at Chhata Mela, the accused persons gherowd the defacto complainant and his brother Amit Singh Sardar and confined them and assaulted them. The accused persons also snatched the Cell-phones of the defacto Complainant and also his brother's. The accused persons also looted an amount of Rs. 1,200/- from the Pocket of the defacto complainant. The numbers of the Cell-Phones are 9547317210 and 8158092957.
6. That it is submitted that the defacto complainant requested the accused persons to return the Cell-phones of them but they deny and also threatened to kill the defacto complainant and his brother.
7. That due to fear, the complainant failed to inform the matter to the Police immediately but when the accused person started regular threatening, the complainant informed the matter to the Police of Purulia (M) Police Station.
8. That the Purulia (M) P. S did not make any receive copy of the same as such the defacto complainant send the Written Complaint to the Officer-in-Charge of Purulia (M) P. S. by Registered Post with A/D. The Police received the same but till date no case has been started.

That as the Police did not start any case against the accused person, the complainant also filed an application before the Superintendent of Police disclosing all the material facts of the case but till date no case has been started by the Police as such the complainant is filing the present petition before your Honour.

It is, therefore, prayed that your Honour may be graciously pleased to forward this petition to the Officer-in-Charge of Parolia (M) Police Station for starting a case against the above mentioned accused persons treating this petition as F.I.R. and to submit report.
