The humble petition on behalf of the petitioner above-named;

Most respectfully begs to state:

1. That the complainant and all the accused persons are resident of village & post.-Belkuri , P.S.Purulia(Mfs) , Dist.-Purulia , West Bengal and within the jurisdiction of this Ld. Court .
2. That on the date of occurrence i.e., on 12/05/2018 at about 5 p.m. at Noru Gope Manasa Mandir the accused persons namely Srimanto Gope , Ranjit Gope being armed with Farsa , Kural in their hands suddenly attacked to the petitioner without any reasonable cause .

The complainant raised objection against the said illegal activities of the accused persons, but the accused threatened to the complainant and used their arms and target to the petitioner. At that time petitioner rescue himself from the accused persons. After some time Srimanto Gope and Ranjit Gope along with others twenty two accused persons being armed with Farsa, Lathi, Kural, Tangi etc. in their hands with forcibly and illegally entered into the complainant house and destroy all the utensil and furniture and took Rs.5000/-, ornaments to broken the aimira. Soon after when all the accused persons entered into the petitioner house all the family members of the complainant flew away from their house. After few hours about 10 P.M. when all the family returned to their house and saw that all the furniture, utensil, house was destroyed.

3. That there after the complainant informed to O/C Purulia (Mfs.) against the accused stating the aforesaid facts but O/C Purulia (Mfs.) did not take any action against the accused persons till today accordingly complainant reported the matter to the S.P. Purulia on 17/08/2018 but till today police did not take any steps against the persons. The accused persons still now threatening to the complainant.

Frankly, the complainant and the other complain before the O/C Purulia (Mfs.) though accused persons but O/C Purulia (Mfs.) did not take any action against the accused persons.

4. That there is clear the petitioner subjecting to assaults, theft, house trespass, destroy the article of the house and which offences punishable u/s-323, 325, 379, ~~400~~, 506, 34 of Indian Penal Code.

It is, therefore, prayed that your Honour may graciously be pleased to direct the police of Purulia(Mfs.) police station to treat this petition of complaint as F.I.R. and to cause investigation in respect of the alleged incident in provisions of u/s 156(3) Cr.P.C.

And for which act of kindness your petitioner as in duty bound shall ever pray.
