Most respectfully beg to state :

1...That on 11/10/2018 at about 5.00 P.M. while the mother of the complainant namely Ujifa Bibi doing her household work with other female members of her family suddenly all the above named accused persons armed with deadly weapons like axe, sword, iron rod, sticks etc. forcefully entered in to the house of the complainant and started to abuse the female members of the family of the complainant with filthy languages after alleging them as witches and started to beat them mercilessly.

2...That when the mother of the complainant Ujifa Bibi came to their rescue from the hands of the accused persons suddenly all of the accused person also attacked upon her and started to beat her by alleging her as an witch. The Accused No.2 namely Sk. Masr S/O. Lt. Sk. Hadis all of a sudden hit upon the heads of the mother of the complainant Ujifa Bibi with a sharp cutting weapon out of which the mother of the complainant sustains serious bleeding injury on her head and was admitted to Deben Mahato Sadar Hospital, Purulia and wherein she got seven stitches in her head and was in critical condition.

3...That as the complainant and other male family members were busy in the treatment of his mother at D.M. Sadar Hospital at Purulia, on the very next day i.e. on 12.10.2018 all the accused persons again came to the house of the complainant and ransacked the house of the complainant and finally demolished the entire mud build house of the complainant and also beaten the brother of the complainant Sk. Ekbal mercilessly who was also admitted and treated in the D.M. Sadar Hospital at Purulia on the same day .

4...That the complainant has lodged a typed copy of complaint (Typed under instructions of the Complainant) before the Officer in Charge Purulia (M), P.S. on 12.10.2018 but unfortunately reason best known to him, the officer in charge of Purulia (M) P.S. despite of repeated assurance could not taken any action against the accused persons till date. The accused persons roaming freely in the area desperately and started to threaten this homeless complainant and his family members repeatedly with dire consequences. The complainant and his family members passing each and every day out of fear, mental agony and recurrence of the offence.

5...That the complainant then send the same complaint again on 31/10/2018 with registered post to the O.C. Purulia (M), P.S. and as such no action has been taken against the accused person.

6...That upon aggrieved and having no option left the complainant on 12.11.2018 the complainant send a typed complained before the S.P. Purulia for taking proper action

against the accused persons but till date no effective measure has been taken against the accused persons.

- 7..That the complainant findings no other alternatives compelled to file this Misc Petition u/s 156 (3) of Cr.P.C. before this Lt. Court seeking proper remedy against the accused persons.
- 8..That the cause of action arise at village – Tatari, P.S. Purulia (M) and within the jurisdiction of this Lt.Court.

It is therefore prayed that your honour may graciously be pleased to admit this Misc. Petition and treating the same as a F.I.R. u/s 156(3) of Cr.P.C. be pleased to direct the O.C. Purulia (M) P.S. to investigate the case properly as alleged.
