I Sri Prashant Kishor, S/O - Kishori Prasad, A.E. & Station Manager of Telkalpara CCC of WBSSEDCL do hereby lodge my complaint empowered by the Electricity (Amendment) Act-2007 to the effect that Ritesh Kumar Jhunjunwala S/O Lt.Om Prakash Jhunjunwala of N.C.Das Gupta Road, Purulia, PS-Purulia(T) has committed theft of electricity under section 135(1)(a) as detailed here under.

Today, i.e. on 06.12.2018 I, Prashant Kishor (AE&SM), along with Sri Debdas Bhattacharjee, Sr.SAE(E), Sri Chinmoy Maity, SAE(E) of Telkalpara CCC, WBSSEDCL conducted a raid programme at village Baikata under Purulia(M) P.S. When our team at about 11.00 A.M. entered to the Commercial premises i.e. Brick field of Ritesh Kumar Jhunjunwala situated at Vill-Baikata, P.O.-Biltora, P.S.-Purulia(M), we found that he was enjoying electricity dishonestly by means of Direct hooking from nearest LTOH line and run water pump motor set, thus WBSSEDCL losses revenue. As theft of electricity was detected in presence of the local witnesses, hooking wire dismantled and seized and seizure list prepared. The seized material labeled in presence of the local witnesses. The inspection team left the aforesaid location at about 11.30 A.M. after completion of inspection & necessary formalities.
