I SI Debasish Bondyopadhyay Officer - in - Charge Purulia (M) PS do hereby the Suo - motu complain against the following persons namely 1) Atul Mahato (29 yrs) S/O Naru Mahato 2) Lalit Mahato (39 Yrs) S/O Ajit Mahato 3) Khagen Mahato (65 Yrs) S/O Lt Naran Mahato all three of Vill-Bhabanipur, 4) Asish Mukharjee (32 Yrs) S/O Lt Ashok Mukharjee Of Chanchra 5) Manu Bauri (38 yrs) S/O Lt Sasthi Bauri of Hutmura 6) Nirmal mahato (31 Yrs) S/O Rajendranath Mahato of Dhansura All of PS-Purulia (M), Dist - Purulia and 100/150 BJP Supporters. It was to mention that today (13/12/18) was notified that the Board formation of Hutmura Gram Panchayet would ensued at the office building of Hutmura Panchayet office and ample of Police arrangement was timbered for that purpose inasmuch as the area of the Panchayet Building was promulgated with the proceeding of 144(2) Cr.P.C by the SDO (sadar) Purulia. I along with force was also present at the Hutmura GP Office vide Purulia (M) PS GDE No 622 dated 13/12/18 , accompanied by my superior to supervise the duty of the Police posse who was detailed for that purpose. After the accomplishment of that board formation at about 14:45 hrs, the candidates of BJP Party left the office building with shouting and instigated the assemblage of BJP supporters who were equipped with lathi , pieces of bamboo, brickbats etc , waiting anomalously outside of the building. Subsequently, the multitude of 100/150 BJP supporters after getting interlocution moved forward the gate of the Panchayet Building and besieged the main outlet as well as the road (NH 60A) with a view to detain the BDO Purulia II who was in the office building and they did it for hours. During the detention of the BDO Purulia II, the mob used indecent and nasty language to the BDO Purulia II. We tried to convince the mob but the mob became furious and started to hurl brick bats aiming at the Police with a view to kill us without paying any heed to our words. For that unlawful act of the mob some police personnel received grievous injury from the brick bats. Finding no other option, in consultation with my superior, I declared the mob unlawful and asked the multitude to leave the place anon. But the mob did not pay any heed to my words and became more furious. Then I ordered to use the Gas to disperse the furious mob and the one round Gas was used but the mob did not disperse .Subsequently I, along with force pushed the mob back and rescued the BDO Purulia II from the Office building of the Hutmura Gram Panchayet and she went away. Subsequently, the mob was thrown back and dispersed. However we could be able to nab Six (06) persons who were disclosed their name and address as noted above. The above noted persons were leading the agitated mob .On 13/12/18 at about 17:05 hrs to 17:35

hrs, the above noted persons were nabbed after observing all legal formalities regarding the arrest with a view to initiate a specific case against 1) Atul Mahato (29 yrs) S/O Naru Mahato 2) Lalit Mahato (39 Yrs) S/O Ajit Mahato 3) Khagen mahato (65 Yrs) S/O Lt Naran Mahato all three of Vill-Bhawanipur, 4) Ashish mukharjee (32 Yrs) S/O Lt Ashok Mukharjee Of Chanchra 5) Manu Bauri (38 yrs) S/O Lt Sasthi Bauri of Hutmura 6) Nirmal mahato (31 Yrs) S/O Rajendranath Mahato of Dhansura All of PS-Purulia (M), Dist - Purulia and 100/150 BJP Supporters for obstruction in public way of navigation and for wrongful confinement to the public servant and for obstructing public servant in discharge of public functions and for using indecent and nasty words to the BDO Purulia II and for obstructing the National Highway and for assaulting to deter the public servant from discharge of his duty. Lathi, pieces of bamboo, brickbats were seized from the possession of the above persons as well as from the PO 18:05 hrs to 18:45 hrs in prescnce of witnesses and accused persons. I moved through the arca for local witness but none was willing to put signature down in the seizure list. The injured police persons were medically treated at Purulia Sadar Hospital.

Consequently, I initiated the Purulia (M) PS case no 266/18 dated 13/12/18 U/S 147/148/149/186/283/323/325/332/333/307/342/353/506 of the IPC and read with section 8B of the National Highway Act 1956 against the supra noted persons and 100/150 BJP supporters and arranged for its investigation.
