Dear Sir,  
I do hereby lodge complaint empowered by enabling the electricity act, 2003 subsequently electricity (Amendment) act - 2007 to the effect that Pronobesh Chandra (present user) was enjoying electricity unauthorisedly i.e. by passing of energy meter by cutting of incoming service connection cable and due to this reason he has committed theft of electricity U/s 135(I)(b) of the electricity (Amendment) act - 2007 on 07/12/18 at 13:30 Hrs.

Entered the premises of Pronobesh Chandra (present user) VIII, Amlapara, P.S. Purulia (T), Dist- Purulia, having Consumer No. 242023315, Meter No. 084598169 and inspected his/her premises. During the inspection theft of electricity was detected i.e. by passing the energy meter i.e. U/S 135(I)(b) was detected. The details of passing the arrangement was damage installation of the incoming wire and top 2 (two) piece of wire by which electricity directly flow to his house without energy registration in W.B. SEDCL energy meter.

From the above by-passing system he/she uses the following electrical equipments.

- 1) Water pump - 01 no.
- 2) Electric Fan - 04 nos.
- 3) Tube Light - 04 nos.
- 4) Celartv - 02 nos.
- 5) CFL Bulb - 05 nos.

Out of which I seized the following.

- 1) PVC 2 Core Cable along with bypassing arrangement - 12 ft (Approx).
- 2) Metal clad change over switch along with wire - 01 no.

Seizure list was prepared at the site and accused person refuse to sign/signed. The inspection took place at 13:50 Hrs on 07/12/18. The accused person has committed an offence U/S 135(I)(b) of the electricity act-2003 subsequently electricity (Amendment) act - 2007.
