Sir,

In producing herewith 04 accused persons namely (1) Sandip Sahis (22 yrs) s/o Sunil Sahis of Saludahar, PS- Arsha, Dist- Purulia; at present c/o Sarshan Singh at Telidih, Adarsha Colony, PS- Chas, Dist- Bokaro, Jharkhand, (2) Nilkantha Sahis (21 yrs) s/o Arun Ch Sahis of Kathowari, PS- Pinrajora, Dist- Bokaro, Jharkhand, (3) Dinesh Sahis (22 yrs) s/o Tarani Sahis of do & (4) Mithun Kumar (19 yrs) s/o Ganesh Prasad Singh of Lakha, PO- Basbhata, PS- Sambhuganj, Dist- Banka, Bihar, under arrest and seized articles (1) One Black- Blue coloured Hero Splendor Pro motorcycle without number plate and having Chassis No MBLHA10ASDHC32296 & Engine No HA10ELDHC34410 (2) One Grey-Black coloured Hero Passion Pro motorcycle without number plate and having Chassis No MBLHA10A6EHD73216 & Engine No HA10ENEHD04993 & (3) 06 Keys likely of motorcycle under proper seizure list sealed and labeled, duly signed by the witnesses and accused persons, I, SI Soumyadeep Mallick do hereby lodge complaint against the above noted accused person for committing an offence punishable U/S 379/411/413/414 IPC. Today (23.12.2018) at 16:25 hrs, in course of my mobile duty (vide Purulia (T) PS GDE No 1277 dated 23.12.18 & C.C. No 3816/18), received a reliable source information that above noted persons, riding on two motorcycles without number plate are coming from Chas moth side towards Purulia Town on Purulia - Ranchi road.

The source also informed that they are coming to thief motorcycles from Purulia town area. I informed the matter to O/C, Purulia (T) PS. As per direction, myself along with my source and C/246, Chanchal Chakraborty, C/1234, Mantala Mondal, JC/1067, Prasanta Malla, HG/3442, Santi Kundu, started sudden Naka checking near Judge bungalow moth on NH (18 Purulia - Ranchi road) to work out the information.

Today i.e. 23.12.2018 at 16:55 hrs reached by the side of a "Tentul" tree near Judge Bungalow moth on NH 18 and started sudden Naka checking with proper briefing. Kept watch at the pacca road extended between Chas moth & Purulia. At about 17:15 hrs, 02 motorcycle riders with one pillion rider with each identified as Sandip Sahis, Nilkantha Sahis, Dinesh Sahis & Mithun Kumar by my source arrived at the Naka point. We detained them. Being asked, they disclosed their identities as (1) Sandip Sahis (22 yrs) s/o Sunil Sahis of Saludahar, PS- Arsha, Dist- Purulia; at present c/o Sarshan Singh at Telidih, Adarsha Colony, PS- Chas, Dist- Bokaro, Jharkhand, (2) Nilkantha Sahis (21 yrs) s/o Arun Ch Sahis of Kathowari, PS- Pinrajora, Dist- Bokaro, Jharkhand, (3) Dinesh Sahis (22 yrs) s/o Tarani Sahis of do & (4) Mithun Kumar (19 yrs) s/o Ganesh Prasad Singh of Lakha, PO- Basbhata, PS- Sambhuganj, Dist- Banka, Bihar. Sandip Sahis was driving one Black- Blue coloured Hero Splendor Pro motorcycle without number plate and having Chassis No MBLHA10ASDHC32296 & Engine No HA10ELDHC34410 and Mithun Kumar was as pillion rider behind him. Nilkantha Sahis was driving one Grey-Black coloured Hero Passion Pro motorcycle without number plate and having Chassis No MBLHA10A6EHD73216 & Engine No HA10ENEHD04993 and Dinesh Sahis was as pillion rider behind him. On interrogation, they confessed that, they have stolen many motorcycles from Purulia town area. Those motorcycles with them are also stolen motorcycles which were stolen by them recently from Purulia town. Today they were also coming to Purulia town for committing theft of motorcycles. Meanwhile, we searched for public witnesses with the help of accompanying force. After a while two public witnesses namely (1) Balaram Nandi s/o Lt Gobardhan Nandi of Namopara Ward No 19, Purulia, PS - Purulia (T), Dist - Purulia, (2) Shibu Gorai s/o Lt Manmatha Gorai of Nimtar, Ward No 5, Purulia, PS- Purulia (T), Dist- Purulia became ready to assist us in conducting search & seizure. I offered the said detained person to search our persons before get them searched. Accordingly they conducted search of our persons but nothing was found except our official belongings and accordingly, I prepared NIL seizure list in presence of witnesses. At first myself with the help of force searched Sandip Sahis and his belonging at the spot and found 02 Keys likely of motorcycle in the right side pocket of his pant. The riding motorcycle was already with him. Accordingly I seized the Black- Blue coloured Hero Splendor Pro motorcycle without number plate and having Chassis No MBLHA10ASDHC32296 & Engine No HA10ELDHC34410 and 02 Keys likely of motorcycle under proper seizure list duly signed by the public

witnesses, police witnesses and accused person. During search of Mithun Kumar 01 Key likely of motorcycle was recovered from the right side pocket of his pant. Seized that key in proper way. Then I searched Nilkantha Sahis and his belonging at the spot and recovered 01 Key likely of motorcycle in the left side pocket of his pant. The riding motorcycle was already with him. Accordingly I seized the Grey-Black coloured Hero Passion Pro motorcycle without number plate and having Chassis No MBLHA10A6EHD73216 & Engine No HA10ENEHD04993 and 01 Key likely of motorcycle under proper seizure list. During search of Dinesh Sahis 02 Keys likely of motorcycle were recovered from the right side pocket of his pant which were seized also.

During interrogation of them, they confessed that, they have committed theft of many motorcycles from Purulia town area. One notebook was recovered from the possession of accd Sandip Sahis where some numbers of motorcycles were noted. He stated that, those motorcycles have been stolen by them from different places of Purulia town. They have also stolen many motorcycles from various places of Purulia. On perusal it could be learnt that, motorcycles having registration number as JH09U 2814, WB56F 6463, WB56D 4187, WB56H 1296, WB56J 0686, WB56H 0833, WB56F 4984, WB56 8216, WB56F 2346; were noted in the notebook. I also seized the notebook. They stated that, there are some associates of them who are presently at Jharkhand & Bihar states. Those motorcycles are kept concealed by them in their secret hideout. They are running an inter-state racket of motorcycle stealing.


There is no question of having possession those motorcycles by them; accordingly I arrested them, informing ground of arrest, prepared memo of arrest and maintained all formalities regarding arrest.

I, therefore, pray that, a case U/S 379/411/413/414 IPC may kindly be started against the above noted accused person and also for arranging its investigation.
