Sir,

This is to inform you that, I the undersigned, a practicing lawyer of District Judges Court, Purulia namely, Mukul Dixit son of Kalishankar Dixit, resident of Sadarpara Purulia, ward no. 3, P.O +P.S + DIST Purulia, W.B.

Today i.e. on 30/11/2018 at about 3 pm I was returning from G.R.O.(Sadar Court)-Purulia to Purulia District Judges Court in connection with NGR Case no. 2458/18. At that time one person namely Binoy Tudu son of Suklal Tudu Block Sabhapati of JDP, resident of Manbazar, Purulia restrained me near main gate of Purulia District Magistrate Office and directed me not to follow the very root. I than requested him to allow me to go to the Court as because I had to attend some other works. Then suddenly the above named accused person hold my collar and stated abusive languages and assaulted me by kicks and blows. For that I fell down and the said miscreant snatched away my money bag containing Rs. 5,000/-{Rupees Five Thousand} and some loose coins from my pocket. It is to be mentioned that some lawyers and some lawyer's clerk witnessed the incident.

It should be mentioned here that I was at that time with full uniform of a lawyer and as such due to said humiliation I badly suffer from mental agony and physical trauma and I was badly defamed.

Under the above circumstances you are request to take appropriate legal measures against the miscreant so that he may be punished according to the law.
