Sir,

In producing herewith the arrested accused person namely Bipin Kr Yadav S/o Rajendra Yadav of Vill.- Rupow, PS – Rupow, Dist. Nawada, Bihar, driver of truck No. JH 10BB/2039 (12 Wheeler) loaded with stolen coal approx 20 MTs with above noted truck. Fact of the case in brief is that on 09.12.18 myself along with C/468 Raju Roy, C/1057 Albinas Tirkey and C/351 Kanailal Bauri who were on Day Mobile Duty on Raghunathpur – Bankura road and at about 13:45 hrs. received a source information that the above noted truck loaded with coal is coming from Santuri side towards Raghunathpur side. After receiving this information I informed the matter O/C Raghunathpur PS and as per direction of him we had been to Raghunathpur – Bankura road near at Chinpina Rly. Gate and found that the above noted truck loaded with coal is coming from Santuri side. We stopped the said truck and asked the driver to produce the authentic papers in respect of said coal as well as papers in respect of the said truck but he failed to produce the any papers in respect the said coal and truck. It is reasonable to believe that the driver and owner of the said truck collected the said coal either theft or by any fraudulent means and transporting to run a clandestine business for wrongful gains. On interrogation the driver of the said truck confessed his guilt. As such it is every reason to believe that the driver and owner of the said truck No. JH 10BB/2039 transporting coal illegally. As such I arrested the accused driver of above noted truck namely Bipin Kr Yadav S/o Rajendra Yadav of Vill.- Rupow, PS – Rupow, Dist. Nawada, Bihar after observing all formalities regarding arrest. On interrogation he disclosed his identity as noted above. I also seized the truck No. JH 10BB/2039 loaded with approx 20 MTs stolen coal under proper seizure list duly signed by the accused driver and witnesses. No public witness was available there.

I therefore pray before you kindly lodge an FIR against the driver namely Bipin Kr Yadav S/o Rajendra Yadav of Vill.- Rupow, PS – Rupow, Dist. Nawada, Bihar and owner of the truck bearing No JH 10BB/2039 as per law and arrange its investigation.
