The humble petition of the complainant above  
named.

Most respectfully Sheweth:-

- 1) That the complainant's son Uttam Kumar Chakraborty (now deceased) aged about 26years, was an employee of Hero Motor Cycle Showroom (Aswini The Agency) and was returning towards his residence with a motor cycle, along Purulia Barakar Road and after crossing the Shanka Rail Gate, while he reached at the end of the turn of the said road, suddenly dashed behind one Truck bearing Regn. No. JH-16A-5588, which was standing on the said road completely in an invisible condition, and was kept without any proper indication or signal, and most importantly the position lamp of the said truck were also switched-off, and the vehicle was parked over the said road illegally, obstructing the free flow of traffic, in such a manner that nobody could expect that there should be any vehicle at the said spot, completely in full of darkness, violating the traffic rules.

2) That as a result the son of the complainant namely, Uttam Chakraborty sustained multiple severe injuries all over his body and was bleeding profusely and his said motor cycle was damaged completely. Soon after the accident the victim, Uttam Chakraborty was rescued by the local people and was removed to Raghunathpur Super Specialty Hospital, in a very critical condition and the attending doctors after his preliminary treatment referred the victim for any better hospital. Accordingly, on that very night (01.09.2018) the victim was transferred to Durgapur Vivekananda Hospital, where he was admitted, but as the said hospital put a huge budget for the medical treatment of the victim, so the complainant shifted his victim son at the S.S.K.M. Hospital at Kolkata on 02.09.2018, where he was admitted, but the victim finally succumbed to his injuries on 16.09.2018 at around 09:00 Hrs at the said S.S.K.M. Hospital, after suffering a lot of pain.

3) That thereafter P.M. examination was done to the victim at the said S.S.K.M. Hospital at Kolkata and there after the dead body of the victim was removed at Purulia Raghunathpur and the same was cremated on the same. That all the necessary and related documents are enclosed herewith for your Honour's kind perusal.

4) That due to the sudden demise of the son of the complainant, all the family members of the complainant were completely broken down, both mentally and physically, after losing the only son of the complainant and they were passing their days with acute mental pain, agony and financial hardship, as the deceased son of the complainant was the only earning member of their entire family.

5) That thereafter, inspite of several intimations were given to the concerned Raghunathpur Police Station, but the said police authority did not started any specific case in this regard, and finally on 23.11.2018 the concerned Raghunathpur P.S. refused to take the written complaint of the complainant.

6) That finding no other alternative, your complainant informed the entire fact in writings to the Superintendent of Police, Dist. Purulia on 26/11/2018 by way of written complaint with a hope to get proper justice and as such your petitioner have complied the provisions of Sec.154(3) of the Cr.P.C., 1973.

7) That till date no such action has been taken by the police department and as such your petitioner/complainant finding no other way, have compelled to bring the facts and the incident before your Honour's Court to get proper justice and to punish the accused person as per the law of the land, as the offender driver of Truck No. **JH-16A-5588** was completely responsible for the accidental death of the victim, due to his rash and negligent act.

8) That your complainant prays that Your Honour shall be kind enough to give a direction to the Officer-in-Charge of Raghunathpur Police Station, to take cognizance of the said offences and to investigate into the matter by treating the same as an F.I.R. otherwise your petitioner shall suffer irreparable loss.
