Dear sir,

On Behalf of Management of DVC, I do hereby lodge an FIR in respect of theft occurred in Permanent store#3 of Raghunathpur Thermal Power Station, DVC.

The summary of incident occurred is stated hereunder :

On 19-11-18 morning during general visit of Permanent Store#3 by concerned custodian Junior Engineers, some cartoon boxes were found in torn condition and some sealed packages in steel rack were also found in open condition. Upon further checking initially it was observed that some copper and brass equipments and mandatory spare parts were found missing. Further during peripheral through checking of the same building with CISF personnel, one glass window was found in broken condition. The mandatory spares (only copper and brass items/parts) with approximate notional value to the tune of Rs.26.28 lacs are found missing, the detailed list of items missed is enclosed.

In light of above said theft, You are requested to kindly register an HR and necessary enquiry /legal action may be carried out as per the law in vogue.

This may kindly be treated as an FIR in respect of the said theft.
