Having Consumer No 201846469 Meter No: B3892994, and inspected his premises. During the inspection theft of electricity was detected i.e. bypassing the energy meter i.e. U/s 135(1b) was detected. The details of passing the arrangement was damage installation of the incoming wire and another two pairs of bypassing wire by which electricity directly flow to his house without energy registration in WASEDC energy meter.

From the above bypassing system he uses the following electrical equipments: 1) Electric Heater - 01 no. 2) Fridge - 01 no. 3) Electric fan - 05 nos 4) CFL - 04 5) Color TV - 01 no.

Out of which I seized the following:

1) PVC 2 core cable alongwith bypassing arrangement - 15 ft (approx).

Seizure list was prepared at the site and accused person signed. The inspection team left the premises at 2.10 PM on 06/12/18. The accused person has committed an offence U/s 135(1b) of the Electricity Act - 2003 Subsequently electricity Amendment - Act - 2007.

You are requested to take cognizance of this complaint and treat it as FIR and action may be taken as per rule.
