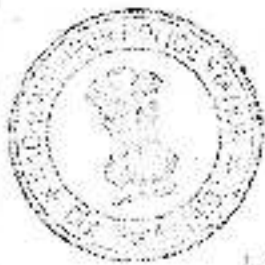

SI Rajat Choudhary, O/C Raghunathpur PS lodged a FIR against the accused persons namely (1) Uttam Kr Mishra S/o Bholanath of Vill.- Hurrah, (2) Patit Paban Chakraborty S/o Lt. Nabin Chakraborty of Vill.- Upar Sankra, (3) Sriroke Majee S/o Lt. Sanatan Majee of Vill.- Durmut, (4) Golak Bihari Mondal S/o Lt. Kanti Mondal of Vill.- Nildih, (5) Chutu Bauri S/o Lt. Panu Bauri of Vill.- Durmut, (6) Sudhir Bauri S/o Lt. Panchanan Bauri of Vill.- Nutandih, (7) Hiralal Paramanik S/o Lt. Sankar Paramanik of Vill.- Nutandih, (8) Lakhikanta Hembram S/o Lt. Binod Hembram of Vill.- Juradh, (9) Goutam Bauri S/o Ratan Bauri of Vill.- Laldanga and (10) Sujal Bauri S/o Subodh Bauri of Vill.- Durmut all are of PS - Raghunathpur, Dist.- Purulia and along with 300 (approx) unknown villagers of local villages to the effect that today (13.12.18) during my law and order duty in c/w the Board Formation at Nutandih Gram Panchayat Office under Raghunathpur P.S., Dist.- Purulia at around 13:15 hrs the unruly mob under the leadership of above noted persons obstructed two winning candidates (TMC) to enter towards the said Panchayat Office. On persuasion I managed the said two winning candidates (TMC) to reach at Nutandih Gram Panchayat Office. After the completion of Board Formation all the winning candidates (BJP) leave the G.P. Office towards Nutandih More but at about 16:05 hrs. the above noted two candidates (TMC) leave the G.P. Office towards Nutandih More but the said unruly mob again obstructed them on the road which road was started Nutandih More towards above noted G.P. Office with dead weapons i.e. lathi, tangi, knife, bhojali etc. but on persuasion I managed to went the above noted two candidates (TMC) from the spot towards Nutandih More after that the unruly mob leave the spot but all are they went to Nutandih More and obstruct free flow of vehicular traffic on Raghunathpur - Barakar Road at Nutandih More under the leadership of above noted persons. I have tried to pursue the agitator to withdrawn the road blockade but they did not any attention in my words and also threw stone and bricks towards police personnel and they also obstruct the police personnel to perform Govt. duty and abused filthy languages to the police personnel. So all the innocent public as well as the Govt. employee were detained there and subjected to enormous suffering. After a long persuasion they withdrew the blockade.
