the meter which was at the outside corridor of the  
house. During the inspection it was found that Md. Sultan  
was enjoying electricity illegally and unauthorisedly, by  
bypassing of energy meter. We took photography of  
the energy meter in presence of his nephew and  
local villagers. But the members of his family did not  
allow us to take the next procedure of the matter

1. Seizure of meter and other articles and
2. Disconnection of service connection line

Besides, they refused to receive any documents i.e. notice,  
seizure list etc by putting their signature,  
Thereby, they have obstructed in the discharge of law  
-ful duties by the Government servant.
