Sub : Complaint lodge against Manik Kumbhakar (28 yrs) S/O - Durjodhan Kumbhakar of Vill. - Agutard, PS - Santaldih Dist- Purulia U/S 46A (c) B.E. Act for keeping/selling of country spirit liquor (Dil se) illegally.

Sir,

In producing herewith arrested accused Manik Kumbhakar (28 yrs) S/O - Durjodhan Kumbhakar of Vill. - Agutard, PS - Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to submit that on 30.11.18 at about 18.45 hrs received a source information to the effect that the country liquor have been kept in his shop at Bus-stand (BCW) illegally with an object to sale. I diarized the information vide Santaldih I.C BCW GDE No- 386 dated- 30.11.2018. To workout the information I along with C/975 - Ashok Saha Roy and C/663 Ashim Kabi both of Santaldih I.C. (BCW) left for the shop of Manik Kumbhakar at Bus-stand (BCW) with the govt. supplied kits box at 18:55 hrs and reached at about 19:05 hrs. Seeing police some unknown persons in front of the shop of Manik Kumbhakar fled away. However, I could detain one among him and asked about his identity. He stated his identify as above and as well as informed also that he gather the country spirit for selling and he was the owner of the said shop. Asked him to produce any valid paper in respect of keeping/Selling of country spirit liquor but he failed to produce the same. Then I seized the following item inside the said shop in proper seizure list in between 19:15 hrs to 19:35 hrs.

- 1] 20 (Twenty) bottles 80UP country spirit (Dil se) each bottles containing 600 ML market value of each being in total approx Rs. 700/- (Seven hundred only)  
01 (one) bottle of 600 ML taken out of the above as sample packet and labeled.

Then I arrested him at 19:20 hrs as he could not show any documents/papers in support of the possession as well as sale of the said articles.

Therefore, I pray before you to start a case U/S 46 A (c) B.E. Act against the said accused Manik Kumbhakar (28 yrs) S/O - Durjodhan Kumbhakar of Vill. - Agutard, PS - Santaldih Dist- Purulia.
