Sub : Prayer for lodging FIR against accd. Nipen Mandal (40 yrs), S/O - Lt. Dakshin Mandal of BCW Bus-Stand, PS-Santaldih Dist- Purulia U/S 46A (c) B.E. Act 1909.

Sir,  
In producing herewith arrested accused Nipen Mandal (40 yrs), S/O - Lt. Dakshin Mandal of BCW Bus-Stand, PS-Santaldih Dist- Purulia along with seizure - list and seized items as described below, I beg to state that on 01.12.18 at about 18.05 hrs during my special mobile duty, I received a source information to the effect that a huge amount of country spirit have been kept at BCW Bus-stand in the house of above noted accused. illegally with an object to sale. I convey the matter to duty officer ASI Soumen Kr. Panda over telephone. He has diarized the information under Santaldih P.S. GDE No- 33, dated- 01.12.18 and as per order of I.C Santaldih P.S. I along with force left for BCW Bus-stand to work out the information with the govt. supplied kits box containing white cloth, sealing wax, seal, papers, carbons, candles etc. I had been to the house of Nipen Mandal, S/o - Lt. Dakshin Mandal at BCW Bus-stand, P.S. Santaldih at about 18:35 hours. Seeing police some unknown persons in front of the house of Nipen Mandal fled away.

However, I could detain one among them and asked about his identity. He revealed his name and identify as above and as well as informed also that he gather the country spirit for selling and he was the owner of the said house. However, I along with said accd. started a search inside the house of Nipen Mandal and found the following item in the said house.

- 1) 18 (eighteen) liters country spirit contained in a plastic jerkin.
- 01 (one) bottle of 600 ML country spirit taken out of the above as sample packet, labeled and sealed with sealing wax.

I interrogated him about the purpose of the stocking and possessing of the liquor said to be country spirit. He replied it was the business of him. On repeated question he told that the persons who fled away were his customers (names of those not known to him). However he could not show any documents/papers in support of the possession as well as sale of the said articles.

As such, I seized the above items as ALAMAT under proper Seizure List between 18:55 hrs and 19:25 hrs & took up one bottle as samples, labeled and sealed accordingly.

Since the allegation against him of possessing, the C.S illegally without any valid papers for the purpose of selling in his house has prima-facie been made out and for the interest of proper investigation. I arrested the above accused at 19:35 hrs accordingly.

Therefore, I pray before you to start a case under proper section of law against the said accused Nipen Mandal (40 yrs), S/O - Lt. Dakshin Mandal of BCW Bus-Stand, PS-Santaldih Dist- Purulia.
