Sir,

In producing herewith one arrested accused person namely Sk. Samim (32yrs), S/o - Sk. Sikandar of Kolagara, PS - Raghunathpur, Dist. - Purulia with seized articles as one country made improvised pipe gun loaded with one round .303 live ammunition in proper seizure list duly signed by the witnesses, I, SI Anower Hossain Khan, In-Charge Santaldih I.C. (BCW) do hereby lodge a complaint that today (18.12.2018) at about 17:25 hrs when myself along with C/975 Ashoke Saha Roy and C/252 Alope Bikash Karan both of Santaldih I.C. (BCW) were engaged in evening patrol duty near Gowai bridge side besides Jharkhand boarder and in that time received a secret information that one person is moving suspiciously beside the culvert near Alladih Jore under Santaldih PS. I inform the information to duty officer and direct him to note down the fact in G.D. He diarized the matter in G.D. vide Santaldih I.C. (BCW) G.D.E. no. 202, dated - 18.12.2018 and myself along with force left for Alladih jore to work out the information. Myself along with force reached near the culvert at about 17:45hrs and found a person was moving suspiciously on that place and after seeing the police vehicle he tried to fled away. After hot chase, we could able to intercept him. Being asked he disclosed his identity as above. But he gave in-coherent statements for his presence there. Then I searched him and found one country made improvised pipe gun loaded with one round .303 live ammunition from his exclusive possession. But he failed to produce any such valid documents in respect of possessing of said fire arms and ammunition. So, I seized one country made improvised pipe gun loaded with one round .303 live ammunition in between 18:05 and 18:20 hrs after preparing proper seizure list duly signed by the witnesses. I also arrested the above noted accused person in 18:30hrs after maintaining all the formalities regarding arrest as he illegally possessed fire arms and live ammunition to use those for unlawful purpose. I also tried to collect the public witnesses but the place was lonely and nobody was available there to sign on the seizure list as public witness. After return to P.S. myself produce the arrested accused along with seized fire arms and live ammunition to start a specific case as per law.

Under above circumstances, I, therefore, pray that a case U/S 25(i)(a) of Arms Act may kindly be initiated against accused Sk. Samim (32yrs), S/o - Sk. Sikandar of Kolagara, PS - Raghunathpur, Dist. - Purulia.
