I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Dibakar Acharya s/o Sunil Acharya of Village- Chakatta, P.O- Adra, P.S- Adra, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 18/01/2019 at about 4:30 PM, Sri KHAGENDRA DAS, Station Manager Adra CCC Customer Care Centre, WBSEDCL along with,

Entered the premises of Dibakar Acharya, s/o Sunil Acharya of Village- Chakatta, P.O- Adra, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by illegal hooking from nearest L.T.O.H Line.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) TV = 1 No's = 1x80 watt
- 2) Fan = 2 No's = 2x60 watt
- 3) CFL = 2 Nos = 2x16 watt

Out of which we seized the following:

Hooking device with 5 meter wire (black and white)

The seizure list is prepared at the site and the accused person signed in the seizer list.

The inspection team left the above premises at about 4:45 PM on dated 18/01/2019. The accused person has committed an offence U/S-135(i)(a) of the Electricity (Amendment) Act-2007. You are requested to take cognizance of the complaint and treat it as F.I.R and action may be taken as per Rule.
