I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Dibakar Acharya,

P.S- Adra, Dist-PURULIA has committed theft of Electricity U/S-135 of the Electricity (Amendment) Act-2007.

On dated 18/01/2019 at about 4:30 PM, Sri KHAGENDRA DAS, Station Manager Adra CCC Customer Care Centre, WBSEDC along with,

Entered the premises of Dibakar Acharya, S/o Sunil Acharya of Village- Chakalta, P.O- Adra, P.S- Adra, Dist-Purulia and inspected his premises.

During inspection theft of Electricity was found, i.e. he/she was using Electricity dishonestly by illegal hooking from nearest LTOH line.

Supply i.e. U/S 135 was detected.

From the above system he/she was using the following Electrical equipments i.e.

- 1) TV = 1 NO's = 1×80 Watt 3) CFL = 2 NO's = 2×16 Watt
2) Fan = 1 NO's = 2×60 Watt

Out of which we seized the following:

Hooking device with 5 meter wire (Black and white)

The seizure list is prepared at the site and the accused person signed in the seizer list.
