In producing here with one arrested accd namely Teju Gope (55yrs.) S/O Lt. Jagu Gope of Vill Hetjari, P.O- Uparjari, P.S.-Arsha Dist-Purulia along with following seized articles viz -

1) One old Bicycle .

2) one white colour plastic container with approx 20 ltrs of cholai,

3) one white colour plastic container with approx 10 ltrs of cholai,.

(Approx 500 ml taken out from the above containers as sample packed with sealing wax)

I ,SI Hari Charan Ghosh of Arsha PS do hereby lodged a written complaint against the above noted accused person to the effect that today 29.01.19 at about 16:10 hrs I along with ASI Ujjal Rajak of Arsha PS and C/236 Akhil Mitra, C/252 Anil Tamang, both of SAP 7th Bn camp at Arsha PS left for special raid duty vide Arsha PS C.C no-247/19 dtd 29.01.19 & Arsha PS GDE no 1094 dtd 29.01.19 . At about 17:05 Hrs when we are near Hetjari more under Arsha P.S. we found one person is going towards Hetjari Village with two white colour big plastic container through bicycle. Seeing us to proceed towards him, the person tried to fled away. Somehow we managed to intercept him & found approx 30 liters of colourless liquid containing with two jarican smelling like cholai inside the container. On asking I confirmed that the liquid is cholai & he disclosed his name as mentioned above. He also informed that he will transport this cholai spirit to other village. He failed to produce any valid document to posses & transport cholai spirit. So I seized all the implicating articles as noted above under a proper seizure list from his exclusive possession in presence of witnesses and properly sealed and labeled duly signed by the accused person and witnesses among which one bottle (500 ML) of Cholai were kept as sample file with label. During interrogation he confessed his guilty. So, I arrested him after observing all the formalities issuing memo of arrest as the accused person is liable for prosecution u/s 46A(c) of The Bengal Excise Act, 1909.

I therefore pray that a specific case may kindly be started against the accused namely Teju Gope (55yrs.) S/O Lt. Jagu Gope of Vill Hetjari, P.O- Uparjari, P.S.-Arsha Dist-Purulia U/S 46A(c) The Bengal Excise Act, 1909, and arrange it's regular investigation.
