Sub: Lodging F.I.R against Faijul Alam, S/o. Lt. Majbul Hoda for unauthorized use of Electricity by way of bypassing the Energy Meter u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007).

Sir,

I Sri Amitava Choudhury, S/O Lt. Sajal Kr. Choudhury, D.E & Station Manager of Balarampur CCC of WBSEDCL do hereby lodge complaint against Faijul Alam, S/o. Lt. Majbul Hoda resides at Vill - Barabazar Road, Balarampur, Po. Rangadih, PS : Balarampur, Dist. Purulia to the effect that received an information that the aforesaid accused person is committing theft of Electricity in his residence by way of tapping the incoming service cable to bypass the proper registration of units in the Energy Meter of WBSEDCL.

Acting upon such information today on 21.01.2019 from 2.20 PM to 3.05 PM I, along with Sri Ramendra Narayan Sinha, S.O. (Reid D.S.P.), Sri Sankar Ch. Mahato, Linesman, Sri Dayamoy Mahato, TSH, S&LP Unit, Purulia Region, and other officials of WBSEDCL has inspected the premises of Faijul Alam and held raid after serving Notice duly received by the representative of the accused.

During raid and inspection it was detected that accused Faijul Alam is using electricity dishonestly by way of tapping the incoming service cable to bypass the proper registration of units in Energy Meter of WBSEDCL. Through this bypass arrangement he is using 1No. 1 H.P Water Pump & 3 Nos. CFL having connected load 0.806 KW. The Service Connection of WBSEDCL bearing Consumer ID : 242037007 stands recorded in the name of Santul Mia, and Faijul Alam is the actual user of that Service Connection which has been disconnected on detection of theft of Electricity.

I prepared Inspection report in presence of the of the representative of the Accused and assessed the Load as 0.806 Kw. Details have been mentioned in the Inspection Report and duly signed by the representative of the Accused.

I directed Sri Sankar Ch. Mahato, Linesman to disconnect the Service Connection of the above stated Consumer ID on which Faijul Alam is the actual user. Accordingly they disconnected the aforesaid Service Connection and removed the energy meter with bypass arrangement.

I prepared seizure list in presence of witnesses, details of seizure have been mentioned in the seizure list and obtained the signature of the representative of the accused. A copy of the seizure list was handed over to the representative of the accused. The local people gathered there witnessed the incident but refused to sign on the Seizure list and inspection report.

For this activity of theft the WBSEDCL has sustained huge financial loss in terms of revenue.

It is well evident that the above mentioned accused person has committed offense u/s 135(i)(a) & 135(i)(c) of Electricity Act 2003 (Amended in 2007).

Kindly treat this complaint as FIR and take necessary action against the accused.
