Sub: Complaint against Haripada Kumar (30 yrs) S/O-Sambhunath Kumar of Vill.- Gerua, P.S.- Balarampur, Dist. Purulia to start a cog case U/S 46A(C)B.E. Act.

Respected Sir,

In producing here with one arrested accused person namely Haripada Kumar S/O-Sambhunath Kumar of Vill.- Gerua, P.S.- Balarampur, Dist. Purulia along with seized 20 (twenty) sealed country spirit bottles (DIL KHUS) (details of seized articles are mentioned in attached seizure list), I beg to submit that today at about 05:05 hrs. I received a credible source information that one person namely Haripada Kumar S/O-Sambhunath Kumar of Vill.- Gerua, P.S.- Balarampur, Dist. Purulia is selling country spirit without any valid license from his own shop at Gerua under Balarampur P.S., Dist.-Purulia. Accordingly, I along with force left for Gerua village to work out the source information and held raid in the shop of accused person.

During search with the help of accompany force, we found that the said person is selling country spirit bottles at his own shop. On demand, he failed to produce any valid documents/ License in respect of selling and keeping of said country spirit. Accordingly, I seized all the sealed country spirit bottles (details in seizure list) after preparing proper seizure list duly signed by the witnesses and labelled sample bottles. Total 12 (twelve) litters country spirit has been seized, total value of the said seized spirit is Rs- 700/= (Seven hundred only) and arrested him after preparing proper arrest memo as he committed offence U/S 46A(C) B.E. Act and supply one copy to him.

Under the above circumstances and fact, I therefore pray that a cog case may kindly be started U/S 46A(C)B.E. Act against the arrested accused person namely Haripada Kumar S/O-Sambhunath Kumar of Vill.- Gerua, P.S.- Balarampur, Dist. Purulia and arrange for its investigation.
