Has committed theft of electricity U/S 135/..... of The Electricity Act 2007.

Entered the premises of Siddheswar Ghosal S/o Lt. Mohulal Ghosal and inspect his/her premises. During inspection theft of electricity was detected i.e. he/she was using electricity dishonestly by drawing illegal hooking from the nearest L.T.O.H line of WBSEDCL e.l. u/s 135 (1)(b) was detected.

From the above arrangement he/she was using the following electrical equipments:
