Sub - Complaint against unauthorised mining operation.


Respected Sir

It has been reported that some unauthorised persons conducting mining operation of metal stone in contravention with Rule- 3 of West Bengal Minor Mineral Concession Rules - 2016 over Plot No 1079, 1229, 1316, 1317 and 1360 of Mouza Dighardih, JL No 105, within this Block Jurisdiction.

It has also been reported that the unauthorised persons using mining machinery to excavate metal stone over the plots in question.

As such unauthorised mining operation is punishable under Rule 50 of WBMM Concession Rules 2016 and cognizable in the Code of Criminal Procedure'1973 and attracts Section 379 of IPC'1860, you are requested to take necessary action as per law. The competent staff of the office of the undersigned may assist you to identify the plots in question.
