I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007 to the effect that Jagannath Mahato, S/O Ajit Mahato of Vill- Raidih, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally by unauthorized Meter from nearest LT OH line with the help of Service cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

At About 06:15 P.M., entered into the premises of Jagannath Mahato, S/O Ajit Mahato, of Vill- Raidih, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill- Raidih, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Jagannath Mahato, S/O Ajit Mahato of Vill- Raidih, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally by unauthorized Meter from nearest LT OH line with the help of Service cable in his premises at Raidih having connected load 0.117 KVA.
