Sir,

I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that DIPAK CHAND KATARUKA S/O LT. SITARAM KATARUKA of Vill- HERBONA, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorizedly i.e. 'B' Phase meter bypassing by shorting incoming and outgoing connection while the other 2 phases i.e. 'R' phase and 'Y' phase were okay. He has committed theft of electricity U/S 135(1)/b of the electricity (Amendment act-2007).

On 29.01.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (2) SRI RAMENDRA NATH SINHA, SO(Retd DSP), S&LP unit, Purulia Region Office, WBSEDCL

At About 01.45 P.M., entered into the Brick field of DIPAK CHAND KATARUKA S/O LT. SITARAM KATARUKA of Vill- HERBONA, P.S- Barabazar, Dist- Purulia and inspected his meter and premises at Vill- Herbona, P.S Barabazar, DIST- Purulia.

During inspection, it was found that DIPAK CHAND KATARUKA S/O LT. SITARAM KATARUKA of Vill- HERBONA, P.S- Barabazar, Dist- Purulia was enjoying electricity unauthorizedly i.e. bypassing the 'B' Phase of energy meter by shorting incoming and outgoing connection while the other 2 phases i.e. 'R' phase and 'Y' phase were okay having connected load 7.06 KVA. Moreover the service connection line has been disconnected from pole side.

From the above arrangement he was using the following arrangements:

01. 5 HP water pump - 01 no
02. Electric fan - 03 nos
03. Light(90 watts) - 05 nos
04. CFL (18 watts) - 10 nos

Out of which I seized the following articles:

01. 3 phase energy meter vide meter no. SF708902 along with bypassing arrangements.

Seizure list was prepared at site and the said consumer duly signed on the paper. After process of inspection and seizure list we left the premises at about 02:15 p.m.

The said person has committed an offence U/S 135(1)/(b) of electricity act 2003 subsequently electricity (Amendment) act-2007.

You are requested to take cognizance of this complaint and treat it as F.I.R and action may be taken as per rule.
