I do hereby lodge complaint, empowered by enabling "The Electricity Act, 2003" subsequently electricity act-2007, to the effect that Ganesh Chandra Mahato, S/O Baidyanath Mahato of Vill- Raidih, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally by unauthorized Meter from nearest LT OH line with the help of Service cable and he has committed theft of electricity U/S 135(1)/A of the electricity (Amendment act-2007).

On 18.01.2019, I Sri ANSHUMAN MITRA, A.E. & S.M., BARABAZAR CCC, WBSEDCL along with

- (1) SAHEB SUTRADHAR, S.A.E(E), BARABAZAR CCC, WBSEDCL
- (2) MD QASIM ANSARI, O.E., BARABAZAR CCC, WBSEDCL

At About 06:40 P.M., entered into the premises of Ganesh Chandra Mahato, S/O Baidyanath Mahato, of Vill- Raidih, P.S- Barabazar, Dist- Purulia and inspected his premises at Vill - Raidih, P.S Barabazar, DIST- Purulia.

During inspection, it was found that Ganesh Chandra Mahato, S/O Baidyanath Mahato of Vill- Raidih, P.S- Barabazar, Dist- Purulia was enjoying electricity illegally by unauthorized Meter from nearest LT OH line with the help of Service cable in his premises at Raidih having connected load 0.071 KVA.

From the above arrangement he was using the following arrangements.
