I, Sri Srikanta Makur, S/O Sri Sudhir Makur , residing at "JOGENDRA BHAWAN", 2nd Floor, 2no Joy Shankar Lane, P.O. Uttarpara, Dist. Hoogly and Inspector of Post Offices, Purulia South Sub Division, under Purulia Postal Division with date of birth 28-03-1983 do hereby inform that Sri Sanjoy Kumar Mahato , S/O Late Baidyanath Mahato, Vill-Dhanda, P.O-Khariduara, Dist-Purulia and Gramin Dak Sevak Branch Post Master, Khariduara Branch Post Office in account with Manbazar Sub Post Office under Purulia Postal Division (now under Put Off Duty) while working as Gramin Dak Sevak Branch Post Master, Khariduara Branch Post Office for the period from 21/10/2011 to 29/011/2018 misappropriated Central Govt. Money, the details of which as follows:-


3) Sri Dipak Kumar Sen, Vill-Dhanda, P.O-Khariduara, Dist-Purulia has open a "Sukanya Samridhi Account" bearing no-8765515869 in the name of his daughter at Khariduara Branch Post Office by depositing of Rs1000/-(Rupees One thousand) only on 30,3,2015 and there after he make few transactions in this account as recorded in the pass book up to dated 12.8.2015 found correct.

On 24.5.2016 the depositor made a deposit transaction amounting to Rs700/(Seven hundred) only in his account, made over the amount of Rs700/ along with filled up pay-in- slip(SB-103) to Sri Sanjay Mahato to deposit the same amount in his daughter"s account. Sri Mahato accepted the money, and make deposit entries on the pass book as well as balance after transaction and authenticated the transaction by putting his signature and returned the pass book to the depositor .But Sri Mahato neither accounted for the same amount in Govt. Account on the same date nor subsequently in any date(s).

Sri Sanjoy Kumar Mahato has submitted his written statement dtd 01.12.2018 and admitted the facts of permanent misappropriation from account no cited above amounting to Rs700/(Seven hundred) only. And he also

The depositor of the above account, Sri Dipak Kumar Sen has submitted his written statement dtd 28.11.2018, stated that he made all the transactions as noted in the pass book by himself and never received any counter foil of pay in slip from GDSBPM Sri Mahato and he also not aware of the system and therefore he never asked for the counterfoil after deposit entries made by him.

2) Sri Akhil Chandra Mahatu, Vill+P.O-Kumari, Dist-Purulia open a "Sukanya Samridhi Account" bearing no-8765516008(non CBS No-5155389) in the name of his daughter Sritama Mahat at Khariduara 8.0 on 30.3.2015 with initial deposit of Rs1000/ (Rupees One thousand) only. There after he make one transactions in this account as recorded in the pass book dated 10.6.2015 found correct.

On 15.7.2016 the depositor made a deposit transaction amounting to Rs1000/(One thousand) only in his account, made over the amount of Rs1000/ along with filled up pay-in-slip(SB-103) to Sri Sanjoy Mahato to deposit the same amount in his daughter"s account. Sri Mahato accepted the money, and make deposit entries on the pass book as well as balance after transaction and authenticated the transaction by putting his signature with date and returned the pass book to the depositor. But Sri Mahato neither accounted for the said amount in Govt. Account on the same date nor subsequently in any date(s).

Sri Sanjoy Kumar Mahato has submitted his written statement dtd 1.12.2018 and admitted the facts of permanent misappropriation from account no cited above amounting to Rs1000/(One thousand) only. And he also admitted that he never used to hand over counter foil of Pay in Slip to the depositor after all deposit transactions.

The depositor of the above account, Sri Akhil Chandra Mahato has submitted his written statement dtd 28.11.2018, stated that he made all the transactions as noted in the pass book by himself and never received any counter foil of pay in slip from GDSBPM, Sri Sanjoy Mahato and he also not aware of the system and therefore he never asked for the counterfoil after deposit entries made by him.

 Sri Jabbar Mahato, Vill+P.O-Kumari, Dist-Purulia open a "Sukanya Samridhi Account" bearing non CBS no-5155549 and CBS no8765526881 on 01.4.2015 at Khariduara B.O with initial deposit amounting to Rs1000/-(Rupees One thousand) only which found correct.

On 30.8.2016 the depositor made a deposit transaction amounting to Rs2000/(two thousand) only in his account, made over the amount of Rs2000/ along with filled up pay-in-slip(S8-103) to Sri Sanjoy Mahato Mahato to deposit the same amount in his daughter"s account. Sri Sanjoy Mahato accepted the money, and make deposit entries on the pass book as well as balance after transaction and authenticated the transaction by putting his signature and returned the pass book to the depositor. But Sri Sanjoy Mahato neither accounted for the said amount in Govt. Account on the same date nor subsequently in any date(s).

Sri Sanjoy Kumar Mahato has submitted his written statement dtd 1.12.2018 and admitted the facts of permanent misappropriation from account

Officer-in-Charge P.S.-Boro Dist.-Purulia no cited above amounting to Rs2000/(two thousand) only. And he also admitted that the never used to hand over counter foil of Pay in Slip to the depositor after all deposit transactions.

The depositor of the above account, Sri Jabbar Mahato has submitted his written statement dtd 28.11.2018, stated that he made all the transactions as noted in the pass book by himself and never received any counter foil of pay in slip from GDSBPM Sri Sanjoy Mahato and he also not aware of the system and therefore he never asked for the counterfoil after deposit entries made by him.

Modus operandi of the case

There is a common modus operandi noticed on the above cases. The depositor has tendered money along with pay in slip (deposit form) duly filled in and pass book to Sri Sanjoy Kumar Mahato and Gramin Dak Sevak Branch Post Master, Khariduara Branch Post Office. Sri Mahato has accepted money from the depositor, made entry of the said deposit in the passbook, raising up to date balance and authenticated the deposits by putting dated signature and returned the passbook to the depositor but did not credited the amount in to the Govt account on the date of deposits or any other subsequent date(s) and used those Govt, amounts for his personal purpose.

During investigation of the case, Sri Sanjoy Kumar Mahato and Gramin Dak Sevak Branch Post Master, Khariduara Branch Post Office has admitted the cases of misappropriation of Govt. money as mentioned above in his written statements dtd 01.12.2018 by non crediting the amount of deposits into Govt. accounts and used the entire amounts for his personal purpose.

By this time, however, it is pertinent to mention here that the entire amount misappropriated by Sri Sanjoy Kumar Mahato as mentioned above in all the three cases has been made good by way of Voluntary deposit (in a lump sum) to the Govi account as "Unclassified Receipt" at Balakdi Sub Post Office under Purulia Postal Division.

As the aforesaid incident clearly speaks of misappropriation of Government Money committed by Sri Sanjay Kumar Mahato being a public servant while holding the post of trust and responsibility, it is requested kindly to treat this complain as FIR into take cognizance of the case for the interest of the department:

Police case no, and development in respect of Police investigation into the matter from time to time may kindly be intimated for onward transmission of the same to the higher authority.
