I do hereby lodge a complaint empowered by enabling the Electricity act 2003 subsequently Electricity (Amendment) Act-2007 to the effect that Sri Tapan Orang S/O- U. Fani Orang of Village- Taparband, P.O- Kharidura, P.S.- Boro, Dist - Purulia, has committed theft of Electricity U/S 135(1)(a) of the Electricity (Amendment) Act-2007.

On dated 18.01.19 at about 11:45 AM, Sri Swarup Mandal, Station Manager, Manbazar Customer Care Centre, WBSEDCL along with,

entered the premises of Sri Tapan Orang, S/O- U. Fani Orang of Village- Taparband, P.O- Kharidura, P.S.- Boro, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthorisely by direct hooking from WBSEDCL's LT on line

During inspection, theft of electricity was found, i.e., he/she was using electricity dishonestly U/S 135(1)(a) was detected. It was also found that he/she was using the following electrical equipments -
