Sub: Complaint against Ranjit Sing (62 Yrs), S/O- Lt. Bipin Sing of Vill- Sursinga PS - Bandwan, Dist - Purulia to start a cognizance case u/s- 46A(C) B.E. Act 1909.

Respected Sir,

In producing herewith one arrested accused person Ranjit Sing (62 Yrs), S/O- Lt. Bipin Sing of Vill- Sursinga PS - Bandwan, Dist - Purulia with seizure of approx 16 liters illicit spirit, containing in 01 black colour tube which carrying said illicit spirit by himself in polythene bag from the possession of above noted accused which was seized under proper seizure list.

I beg to submit that today (18.01.19) during mobile duty in between 17.45 hrs to 17.55 hrs on acting a secret source information I apprehended the above noted person at Agnibil more who was moving towards Agnibil village. After thoroughly searching I found that he was carrying approx 16 liters illicit spirit, containing in 01 black colour tube which carrying said illicit spirit by himself in polythene bag. On interrogation he disclosed his name and address as noted above. On demand he failed to produce any valid documents in re/carding of illicit spirit which is kept 01 black colour tube containing approx 16 ltrs. Accordingly I seized the same under proper seizure list in presence of witnesses, u/s 67 A (C) B.E. Act which is enclosed herewith. As such he was arrested at 17.55 hrs u/s 67 B.E. Act and during arrest the ground of arrest were duly notified issuing arrest memo u/s 50 Cr. P.C. and handed over a copy of the same to arrestee. Out of seized illicit liquor 500ml taken out in a container as sample with sealed & labeled.

The above noted arrested accused Ranjit Sing (62 Yrs), S/O- Lt. Bipin Sing of Vill- Sursinga PS - Bandwan, Dist - Purulia violate section 18(i) B.E. Act, for possession of intoxicating not obtained from a licensed vendor and in contravention and he committed offence u/s 46 A (C) B.E. Act 1909.

It may note here that during raid (1) C/181 Rabban Sekh, (2) C/ 1361 Munshi Kamal Hassan accompanied me.

Under the fact and circumsances I therefore pray a case u/s 46 A (C) B.E. Act. 1909 may kindly be started against Ranjit Sing (62 Yrs), S/O- Lt. Bipin Sing of Vill- Sursinga PS - Bandwan, Dist - Purulia.
