
### The Complainant above named

Most respectfully begs to state:

- 1. That the Complainant along with her family are residing at Village-Nischintapur, within Hura P.S. in the district of Purulia.
- 2. That the husband of the Complainant namely Tagar Gope in the first week of May, 2018 was searching for some job for earning livelihood when upon he met one Jhantu Gope (the Accused Person No.2), a co-villager. At that time said Jhantu Gope was working outside of West Bengal for earning livelihood.
- 3. The Accused Person No.2 asked said Tagar Gope to go with him at his place of work to work as a day-labour. On 24/05/2018 Tagar Gope went to Gopavaram within Andhra Pradesh with Accused Person No.2 and where said Accused Person No.2 engaged him to cook meal for the 20/25 labours in a mess. The other Accused Persons were residing in the said mess alongwith the Accused Person No.2, the Witnesses No.2 to 4 & some others.
- 4. That initially said Tagar Gope used to reside at Gopavaram and cooked meal for the labours of the mess but after few days some labours of the mess used to abuse said Tagar Gope on the allegations of theft and also started quarrel regularly.
- 5. That when such state of things were going on, in the morning of 10/09/2018 the Accused Person Nos. 1, 3 & 4 forcefully took said Tagar Gope at outside of mess at some distance. In the afternoon said Tagar Gope came to the mess and on query of the other inmates of the mess including the Witness Nos.2, 3 & 4, told that the Accused Person No.1, 3 & 4 assaulted him with the active support and provocation of the Accused Person No.2 and snatched away Rs.1000/- from him.
  - 6. That after some time on that date the Accused Person No.1 came to the mess and again took said Tagar Gope with him. In the evening the Accused Persons in drunken condition though returned to mess but said Tagar Gope did not return back. The inmates of the mess asked the Accused Persons about Tagar Gope but they did not give any proper reply. The Witness Nos.2, 3 & 4 and some other persons pressurized them whenupon the Accused Persons disclosed that Tagar Gope was lying in a jungle in drunken condition.
  - 7. That the Witness Nos.2, 3 & 4 and some other persons went to search said Tagar Gope and after some time they found the body of Tagar Gope was lying in jungle. The Witness Nos.2, 3 & 4 and some others brought the body of Tagar Gope at their mess and thereafter the Witness Nos.2, 3 & 4 brought the body of Tagar Gope in an ambulance at his native place. On 12/09/2018 the body of Tagar Gope reached at Nischintapur and the Witness Nos.2, 3 & 4 informed the entire incident to the Complainant & others. Thereafter the Complainant & others brought the deadbody to Hura P.S. & also informed the matter.


- 8. That on the information of the Complainant the O/C Hura P.S. started the U/D Case No.30/18 dt.12/09/2018, and sent the deadbody to Deben Mahato Sadar Hospital, Purulia for Post-Mortem examination.
- 9. That on 12/09/2018 the post mortem examination has been held at Deben Mahato Sadar Hospital, Purulia by the Witness No.5 and the doctor opined that the death of Tagar Gope was due to effect of poisoning.
- 10. That the Complainant has got strong belief that the Accused Persons with some grudge murdered said Tagar Gope by administerining him poison and throw away the deadbody at jungle so that no one can find the deadbody with intention of disposing or causing disappearance of the deadbody.
- 11. That presently the Accused Persons are at Nischintapur and regularly threatening the Complainant & others.
- 12. That the Complainant informed the matter to the O/C Hura P.S. requesting him to take legal steps against the Accused Persons but the police did not take any action in the matter up-till now. On 4/10/2018 the Complainant also informed the matter through registered post but the O/C Hura P.S. did not take any action.
- 13. That the Complainant also informed the matter to the S.P. Purulia on 12/10/2018 but up-till now no action has been taken by the police.
- 14. That thus the Complainant brought this case for the offences committed by the Accused Persons for which they are liable to be prosecuted.

It is therefore prayed that your honour may graciously be pleased to treat this petition as a Complaint under Section-156(3) of the Cr.P.C. & send the petition to the O/C Hura P.S. for investigation & further be pleased to pass necessary order.
