Sub: - Complaint against Rajesh Mahato (31) S/o Adhir Mahato of Vill- Khairipihira, PS Hura, Dist. Purulia to start a cog case U/S-46A(c)B.E.Act.

Sir,

In producing here with arrested accused namely Rajesh Mahato (31) S/o Adhir Mahato of Vill- Khairipihira, PS Hura, Dist. Purulia along with seized Country Spirit bottles DIL SE (details of seized articles are mentioned in attached seizure list), I beg to submit that today on 18.01.19 at 17.05 hrs received a credible source information and according to that information I, SI Bablu Ghosh along with force held raid (17.45 hrs.- 18.25 hrs) in the house of above noted accused person at Khairipihira village under Hura PS against illegal stock and selling of liquor and during the time of raid found that the above noted accused person was stocking and selling country sprit which was kept in his house. On demand, he failed to produce any valid documents/ License in respect of selling and stocking Country Spirit. Accordingly, I seized all the sealed Country Spirit bottles (details in attached seizure list) after preparing proper seizure list duly signed by the witnesses and labeled sample one bottle. Then I, arrested him after preparing proper arrest memo, maintained all formalities regarding arrest as he committed offence U/S 46A(C) B.E. Act and supplied one copy to him. This is to note here that on seeing police party all public/customers fled away. Total 25 (Twenty five) bottles country sprit (DIL SE) have been seized measuring 600 ML each bottle and value Rs. 35 each. Total value Rs- 875/-.

Under the above circumstances and fact, I therefore pray that a Cog. Case U/S 46A(C) B.E Act may kindly be started against the arrested accused person namely Rajesh Mahato (31) S/o Adhir Mahato of Vill- Khairipihira, PS Hura, Dist. Purulia and arrange for its investigation.
