Sir.

In producing here with the arrested Accd. person namely Manjoor Alam Ansary (48) @ Manjoor Ansary @ Murshid Ansary S/O Noor Mohammad Ansary of Vill- Bandhdih tola Dohitard, PS- Joridih, Dist- Bokaro, Jharkhand as disclosed by the arrested accused person along with seized articles under proper seizure list (enclosed here with) i.e. (i) One white colored nylon bag (ii) Exhibit Mark-'A' i.e. one transparent plastic Jaricane along with red colored cap containing 3400 grms. (including Jaricane) of light red colored codeine like mixture (rest mother sample after taken out Exhibit Mark "B' & "C"), (iii) Exhibit mark - 'B" 100 grms. Of codeine as test sample (including bottle). (iv) Exhibit mark "C" 100 grams of codeine as security sample (including bottle). Exhibit mark B & C were collected from mother sample which was 3600 grams (including Jaricane) of light red colored codeine like mixture. All Exhibits are in properly sealed and labeled condition under proper seizure list.

I SI Nimai Chandra Nemo of Jhalda P.S. do herewith lodge a complaint against the above noted accd. person to the effect that on 15.01.19 at 23:25 hrs. duty officer of Jhalda P.S. ASI Sk. Habibul Hasan received a telephonic information from an unknown caller that one person with a white colored nylon bag loaded with illegal narcotic substance (codeine) will come from Khatjuri village side within an hour to Mosina more side on foot to supply the same to its buyer. The matter was diarized vide Jhalda P.S. GDE No- 576 Dtd. 15.01.09 and at once the information brought to the notice of my immediate superior i.e. I/C Jhalda P.S. who immediately endorsed the matter to me for working out the fact. This refers to Jhalda P.S GDE No- 576 Dt- 15.01.19 and as per direction of I/C Jhalda P.S myself along with (i) ASI- Pankaj Gupta (ii) C/12- Gostho Bihari Mahato (iii) C/1376- Tapan Das (iv) C/571- Md. Hasib Khan (v) CD/132- Haydar Ali, all are Jhalda P.S. at once left for Mosina more to work out the information with Govt. Vehicle No WB 56C 8741 and command certificate no. 141 Dt- 15.01.19 vide Jhalda P.S GDE No- 577 Dt-15.01.19 along with weighing machine (Collected from Naru Dutta S/O Lt. Kalipada Dutta of Jhalda Town B.K. Para. Ward No- 4, PS- Jhalda, Dist- Purulia) investigation kit and other necessary inventory items. We took mandatory articles like white papers, carbon papers, brown papers, pen, rubber, stamp with pad, electronic weight machine (ranging from 10 grms to 5 Kgs.), sealing wax, brass seal, candle, match box, thread, gum etc. after preparing inventory list. We reached at Mosina more at 23:45 hrs. where we waited there another twenty minutes then we noticed a person was approaching towards Mosina more from Khatjuri village side with a white colored nylon bag loaded with some articles on 16.01.19 at 00:05 hrs. On getting the smell of Police, said person tried to flee away from there but he was promptly surrounded & we disclosed identity before him and being asked he disclosed his identity as noted above and we informed him that we had specific information that he has illegal narcotic substance (codeine) with him inside the nylon bag and issued notice informing him that as per NDPS Act, the search process may be conducted by any Executive Magistrate or any gazetted officer according to his wish. He informed me that he wants to search should be conducted by an Executive Magistrate, Accordingly as per his wish I requested I/C Jhalda PS to arrange for an Executive Magistrate for the said search process over telephone.

At about 00:45 hrs. I/C Jhalda PS informed me over telephone that no Executive Magistrate could be made available at such odd hours of night. I informed him and issued another notice that I/C Jhalda PS is a gazetted Officer and if he agrees I/C Jhalda PS can conduct the said search process and obtaining his written consent, I intimated I/C Jhalda PS to remain present to supervise the search process.

Mimal chinemo

Around 01:05 hrs. Shri Sanjib Ghosh, Inspector of Police, I/C Jhalda PS arrived at Mosina More under P.S Jhalda. Purulia and issued another notice in writing upon said detained person Manjoor Alam Ansary @ Manjoor Ansary @ Murshid Ansary directing him that he has legal rights to search all the members of raid party before search of him. He conducted a search of all the members of us but nothing objectionable could be found on our person except personal belonging. Govt. arms and ammunition and items mentioned in the inventory list.

In presence and under the supervision of Shri Sanjib Ghosh, Inspector of Police I/C Jhalda PS, search process was conducted and during search we brought one white colored nylon bag inside of which one transparent white colored plastic Jarican along with red colored cap containing light red colored liquid was found. After opening the cap automatic smell was found. A strong suspicion arose that it was codeine mixture and on interrogation Manjoor Alam Ansary @ Manjoor Ansary @ Murshid Ansary admitted that it is the codeine mixture and he is habituated in dealing of such clandestine illegal business of Codeine for commercial purpose for his wrongful gain, knowing the same is a punishable offence. On demand he failed to produce any valid documents or justify regarding the storage of huge quantity of contraband codeine mixture. According to the direction of I/C Jhalda P.S. I weighed the Jaricane and it resulted in 3600 Grams including Jaricane in electronic weighing machine. On reasonable belief, an offence has been committed in respect of recovered liquid substance believe to be codeine mixture from which 100 grms. (including bottles each were taken as test sample and security sample in two bottles each. The said articles were seized U/S 43 of NDPS act. 1985 under proper seizure list duly signed by the witnesses as well as the accused in between 01:30 hrs. to 02:15 hrs. I also supplied a copy of seizure list to the accused. I arrested the detained person maintaining all formalities. The seized bottles were properly labeled and sealed.

In between 02:20 hrs. to 02:35 hrs. I prepared another inventory list containing white paper, carbon paper, brown paper, pen, rubber, stamp with pad, electronic weight machine (ranging from 10 grms to 5 kgs), sealing wax, brass seal, candle, match box, thread, gum, one Jaricane and two small bottles (the Jaricane consists of 3400 grms and other two contains 100 grms each of seized codeine mixture) in presence of witnesses and accused. The entire process was supervised and directed by I/C Jhalda PS, Sri Sanjib Ghosh.

The accused persons are liable for prosecution U/S-21(C)/29 of NDPS Act. 1985 as amended up to date.

Under the above fact and circumstances I like to lodged an FIR against Manjoor Alam Ansary (48) @ Manjoor Ansary @ Murshid Ansary S/O Noor Mohammad Ansary of Vill- Bandhdih tola Dohitard, PS- Joridih, Dist- Bokaro, Jharkhand and others U/S- 21(C) /29 of NDPS Act. 1985 as amended up to date and arrange for its investigation.
