

I do hereby lodge complaint empowered by enabling the electricity act-2003, subsequently electricity (Amendment) act-2007 to the effect that Gobardhan Mahato, S/O:- Jugal Mahato and Bhudeb Chandra Mahato, S/O:- Paresh Chandra Mahato and Bhisam Mahato, S/O:-Shambhu Mahato resident at-Ranidih(Chhota Phuhara) was enjoying electricity unauthorized i.e. hooking from nearest LTOH line and due to this reason he- has committed theft of electricity U/S 135 (1/a)of the electricity (Amendment act-2007) on...21.01.2019...at.....02.00.
