On 17.01.2019 at about 12.40 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01. Shibaram Mahato, HG.TSH, Joypur CCC 02. Sristidhar Mahato, HG.TSH, Joypur CCC, entered the premises of Dhiren Mahato (Current user), S/O-Bhadari Mahato, Con_id-242138382, Meter No-742511 of village-Kusumtikri, P.S- Joypur, Dist- Purulia and found Dhiren Mahato (Current user), S/O-Bhadari Mahato, Con_id-242138382, Meter No-742511 was enjoying electricity unauthorizedly drawing power from the incoming service line of WBSEDCL through green colour CU cable by means meter bypassing to his house premises and connected load found 0.3 KW.
