I do hereby lodge complaint empowered by enabling the electricity act 2003 subsequently the amendment act 2007 to the effect that Khirad Mahato, S/O-Bhukul Mahato of village-Hetkahan, P.S- Joypur, Dist- Purulia has committed theft of electricity U/S 135(1) (a) of electricity act 2003 subsequently amendment act 2007.

On 17.01.2019 at about 01.45 P.M. I Sri Nilanjan Kumar Mondal, AE & Station Manager, Joypur CCC along with 01. Shibaram Mahato, HG.TSH, Joypur CCC 02. Sristidhar Mahato, HG.TSH, Joypur CCC, entered the premises of Khirad Mahato, S/O-Bhukul Mahato of village-Hetkahan, P.S- Joypur, Dist- Purulia and found Khirad Mahato, S/O-Bhukul Mahato was enjoying electricity unauthorizedly drawing power from the LTOH line of WBSEDCL through white colour CU cable by means direct hooking to his house premises and connected load found 0.746 KW. As Khirad Mahato, S/O-Bhukul Mahato committed theft of electric power. So, I seized the following articles after preparing the seizer list in presence of 01. Shibaram Mahato, HG.TSH, Joypur CCC 02. Sristidhar Mahato, HG.TSH, Joypur CCC. The inspection team left the premises at 2.00 P.M.
