Respected Sir,

In producing herewith arrested accused namely Bijoy Mondal (60), S/O – Lt Golak Mondal of village-Kaduri, PS- Kashipur, Dist- Purulia along with seized articles, I beg to report that on 27.01.19 in course of mobile duty myself along with force got reliable source information that one person is selling ID liquor (Cholai Mad) at village Kaduri in his house. Accordingly myself along with C/1233Laxmikanta Mahato and JC/977 Tarun Kadam both of Kashipur P.S reached at Kaduri village in the house of above noted person at about 18:15hrs and found that one person was selling ID.liquor(Cholai Mad) in his house. After seeing police party liquor customers fled away from the spot. On demand the seller failed to produce any valid document regarding selling ID liquor(Cholai Mad). So the above noted accused has committed an offence U/S -46(A)(c) B.E. Act 1909 Amended up-to date. During search I found (1) Ekti plastiker Jariken jahar Madhya anumanik 10 (Ten) Ltr Cholai Mad Varti ache (2)) Ekti plastiker Jariken jahar Madhya anumanik 05 (Five) Ltr Cholai Mad Varti ache.(3) Ekti Plastiker bottole anumanik 200 ml Cholai Mad jaha seizure lister 1 no Alamat theke Sample hisabe alada kora holo (4) Ekti Plastiker bottole anumanik 200 ml Cholai Mad jaha seizure lister 2 no Alamat theke Sample hisabe alada kora holo the above noted articles seized under proper seizure list duly signed by the witnesses in between 18.25 hrs. to 18.55 hrs. I also seized and labeled bottles with sample ID. liquor(Cholai Mad) at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S-67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case U/S 46(A)(c) B.E. Act 1909 against arrested Bijoy Mondal (60), S/O – Lt Golak Mondal of village-Kaduri, PS- Kashipur, Dist- Purulia and arrange for its investigation.
