I also seized and labeled bottles with sample ID. liquor(Cholai Mad) at the spot in presence of accused person and witnesses. Accordingly I arrested the above noted accused person U/S-67 Bengal Excise Act 1909 and informing him the ground of arrest and I prepared arrest memo after maintaining all arresting rule as well as I brought him to P.S. with seized above noted articles.

Therefore I pray before you that kindly arrange to start a specific case U/S 46(A)(c) B.E. Act 1909 against arrested Bijoy Mondal (60), S/O – Lt Golak Mondal of village-Kaduri, PS- Kashipur, Dist- Purulia and arrange for its investigation.
