entered the premises of Asyur Bhowry, S/O At. Aliyan Bhowry of Village- Jitajuri, P.O- Jitajuri, P.S. Manbazar, Dist - Purulia and inspected his/her premises and found that he was using electricity unauthoritatively by direct tapping from WBSEDCL LT line
