Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Subhash Bouri (42) S/O-Lt. Kishan Bouri of Vill- Asanbani, PS- Neturia, District- Purulia with seizure of 20 pcs. Sealed bottles of Dil Se country spirit containing 600 ml. each which were seized under proper seizure list.

I beg to submit that today (29.01.19) at 13:55 hrs while myself along with force were performing anticrime day mobile duty near Ranipur, received source information that one Subhash Bouri (42) S/O-Lt. Kishan Bouri of Vill- Asanbani, PS- Neturia, District- Purulia has illegal stock & selling of liquor in his house at Asanbani village under PS- Neturia. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Asanbani village for work out the information. At 14:15 hrs after reaching at Asanbani village held raid in the house of Subhash Bouri (42) S/O-Lt. Kishan Bouri of Vill- Asanbani, PS- Neturia, District- Purulia and found that the above noted person was keeping / selling liquor which were kept in his house, on demand Subhash Bouri failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 A(c) B.E. Act and he was arrested U/S-67 BE Act and also 20 pcs. Sealed bottles of Dil Se country spirit containing 600 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Subhash Bouri (42) S/O-Lt. Kishan Bouri of Vill- Asanbani, PS- Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1. C/382 Bipad Taran Chatterjee and 2. C/1260 Santosh Soren both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Subhash Bouri (42) S/O-Lt. Kishan Bouri of Vill- Asanbani, PS- Neturia, District- Purulia under proper section of law.
