Sub: Prayer for starting a specific case.

Respected Sir,

In producing herewith one accd. person namely Amit Mondal (22) S/O- Asit Mondal of Vill-Mekatola, PS-Neturia, District- Purulia with seizure of 21 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml. each which were seized under proper seizure list.

1 beg to submit that today (18.01.19) at 12:45 hrs while myself along with force were performing anticrime day mobile duty near Sarbari More, received source information that one Amit Mondal (22) S/O- Asit Mondal of Vill- Mekatola, PS-Neturia, District- Purulia has illegal stock & selling of liquor in his Chalaghar at Mouza Bansbani beside Purulia-Barakar pitch road under PS Neturia. On receiving the information, I informed the matter to you and as per your instruction myself along with force proceed to Bansbani Mouza for work out the information. At 13:05 hrs after reaching at Bansbani Mouza held raid in the Chalaghar of Amit Mondal (22) S/O- Asit Mondal of Vill- Mekatola, PS-Neturia, District- Purulia which is situated beside Purulia-Barakar pitch road under PS Neturia and found that the above noted person was keeping / selling liquor which were kept in his Chalaghar, on demand Amit Mondal failed to produce any valid documentary authority in respect of selling of liquor as well as nobody turned up to produce any valid documents. As such he committed offence u/s 46 Λ(c) B.E. Act and he was arrested U/S-67 BE Act and also 21 pcs. Sealed bottles of Dilkhush country spirit containing 375 ml. each which were seized under proper seizure list duly signed by witnesses and labeled at the time of arrest. During arrest the ground of arrest was duly notified, issued arrest memo u/s 50 Cr. P.C. and handed a copy of the same to arrestee.

The arrested accd. namely Amit Mondal (22) S/O- Asit Mondal of Vill- Mekatola, PS-Neturia, District- Purulia has committed offence u/s 46 A(c) B.E. Act, 1909 for unauthorized possession and sale of liquor.

It may note here that during raid 1, C/278 Ashok Chandra and 2, C/382 Bipad Taran Chatterjee both of Neturia PS accompanied me.

Under the fact and circumstances I therefore pray that a specific case may kindly be started against Amit Mondal (22) S/O- Asit Mondal of Vill- Mekatola, PS-Neturia, District- Purulia under proper section of law.
